5. Manager's Report


a. Financials



Brier Funds have been deposited.

We are up 47K this year in expenses. With rent being \$47K this year, the club is holding the line in terms of expenses

d. Food and Beverage

Small profit of \$6046 this year to date. Margins are on budget.

Assessment of produce costs will be performed in in the new year and adjust menu as necessary.

Liquor expenses will increase 3% in the new year.

e. FYI

Club sponsored 9 participants for Club Coach training last weekend.

Carpets will be cleaned over the Christmas break.

6. Treasurer's Report - Daniel Hennessy

- **a.** Casino Funds plan reached out to AGLC, if don't use the COVID income, then we are operating at a loss. We are reaching out to AGLC to see if the Brier 50/50 and casino money can be used to pay some of our rent.
- **b.** Brier ticket sales (amount of \$157000) The Club and its members did the work in 2022, but at the time of the auditor's report, we did not put this money into the revenue. It makes the most sense to have the Brier income in the year that it was made. Discussion that we set up an accrual for this going forward.



c. <u>Cash flow issues</u> – we have a large amount of money in savings – the interest on this deposit can be considered income, however, it shouldn't affect our not-for-profit status.

\$27000 of the Brier Ticket monies will be dispensed to other local curling clubs who supplied volunteers for the Brier.
